

HVLA Board Resignations & Recalls

Since the fall of 2014, fourteen (14) HVLA Directors have left office by resignation (10) or recall (4). Here they are:

Notice the majority (both groups) are known supporters of balanced funding of services/amenities for **ALL** members (not just golf). Repeated and well-founded rumors have circulated that most resignations were influenced, at least in part, by either negative political behavior or by Assn. functioning-held-hostage by those who support “Golf First.”

In addition, keep the following facts in mind:

- Early 1990’s-2017, “Golf First” Boards systematically neglected non-golf amenities.
 - GM, Rod Wood said Boards had committed “willful failure” (early 2017).
 - Community Center needed demolition due to “willful” deterioration.
- 1995-2015, “Golf First” Boards **Falsified** Fiscal Reports to conceal multiple problems.
 - Uncovered (2015) by “professional” audits, reserve studies & golf consults - All Initiated by a Member-Oriented Board – 2015.
- 1995-2015, “Golf First” Boards allowed “Reserves” to develop \$11+ Million Short-Fall.
- Late 1990’s-2015, Many Election Irregularity Claims – Election Committee Reviewed.
 - 2015-Present, “Election Committee Report” suppressed by Boards.
- 2001-2017, Golf Ops. LOSSES of over \$9.27 Million = Avg. \$545,000 per year!
- 2009-2015, “Golf First” Boards developed \$12 Million Plan --“Hartmann Event Center”
 - Process stopped by Member-Oriented Board, March 2015.
- 2015 – Two professional golf consults advising a “Business Plan” to reduce LOSSES.
 - **Never done!**
- 2015 – Financial consultant advised “Forensic Audit” on Delinquent Accts.
 - **Never Done!**
- 1990’s-Present, “Golf First” Boards kept non-golf members ignorant of governance.
- 1990’s-Present, “Golf First” Boards kept control or quickly regained control of Assn.

“Golf First” Boards have systematically destroyed non-golf amenities via neglect, disenfranchised the majority of non-golf members who now mostly do not vote, created a political-system that eliminates challengers, ignored plans to develop family/kid-oriented amenities and have actually threatened to sue the Assn. if they are not allowed to continue!
